

NOTICE BY GRIZZLY PEAK WATER SALES & DISTRIBUTION, LLC OF ADVICE  
LETTER FOR APPROVAL OF TARIFF SHEETS IMPLEMENTING CHANGES TO THE  
RATES FOR WATER AND SEWER SERVICES AND TAP FEES FOR NEW CONNECTIONS

You are hereby notified that Grizzly Peak Water Sales & Distribution, LLC (Grizzly Peak) has filed an Advice Letter with the Colorado Public Utilities Commission (CPUC or Commission) for permission to file changes to its rates for water and sewer service and system development charges (tap fees) in Grizzly Peak's tariff. The proposed rate changes are the first changes in the rates charged by Grizzly Peak since September 2012 and reflect the increases in costs to serve the customers of Grizzly Peak and to connect new customers to the Grizzly Peak potable water and wastewater treatment systems since the establishment of the current rates. The proposed changes in water and sewer rates will affect all customers and, if approved by the CPUC, will become effective on May 8, 2025. The proposed rates are as follows:

Members of the public who wish to view the Advice Letter at Grizzly Peak's offices must first call its customer service line, (970-884-9126), to make an appointment.

Anyone who desires may either file a written objection or seek to intervene as a party in this filing. If you only wish to object to the proposed action, you may file a written objection with the CPUC. The filing of a written objection by itself will not allow you to participate as a party in any proceeding on the proposed action.

If you wish to participate as a party in this matter, you must file written intervention documents in accordance with the Commission Rules of Practice and Procedure. Anyone who desires to file a written objection or written intervention documents to the proposed action shall file them with the Colorado Public Utilities Commission, 1560 Broadway, Suite 250, Denver, Colorado 80202 at least one day before the proposed effective date.

Members of the public may attend any hearing and may make a statement under oath about the proposed change whether or not a written objection or request to intervene has been filed.
